- Documentary proof of proficiency in English, if appropriate

#### **3. PROGRAMME FEES**

The fees for the whole programme is HK\$99,960 by 12 instalments of HK\$8,330 each payable every 2 months. (Some modules of these programmes are partially included in the list of reimbursable courses for CEF purposes. Students could be reimbursed for up to a maximum sum of HK\$10,000 of the tuition fees.)

Students should note that all fees are subject to review and may be changed by the University.

#### **4. ADMISSION REQUIREMENTS\***

- Holders of a diploma or advanced diploma from recognized post-secondary institutions such as Diploma in Management Studies (DMS) jointly organized by HKMA/HKPU or HKMA/Lingnan University, or equivalent qualifications
- A recognized Diploma / Higher Diploma / Associate Degree in Business or related discipline
- Be proficient in the English language and may be required to provide evidence of proficiency (TOEFL 580 or IELTS 6.5), unless their diploma has been undertaken in an institution where the language of instruction is English
